ORDER

(Under section 86 of the Multi-State Co-operative Societies Act, 2002)

Vide this Department's order of even No. dated 31.08.2021, Shri Dinesh Kumar Sonker, Director (Cooperation) was appointed as Official Liquidator of The Cooperative Store Ltd. (Super Bazar), New Delhi under the provisions of the Multi State Cooperative Societies (MSCS) Act, 2002 and rules made thereunder.

- Whereas Shri Dinesh Kumar Sonker, Director (Cooperation) has superannuated from Govt. 2. service on 31.12.2021. Now, Department of Consumer Affairs (DoCA) being the Administrative Ministry of The Cooperative Store Ltd. (Super Bazar), vide letter dated 22.04.2022 has recommended the name of Shri Dinesh Kumar Sonker, Director (Cooperation) (Retd.) for continuation as Official Liquidator for the The Cooperative Store Ltd. (Super Bazar), New Delhi from 01.01.2022 until an alternate arrangement for appointment of new Official Liquidator is made.
- DoCA has also recommended that the remuneration be paid to Shri D.K. Sonker, Director 3. (Cooperation) (Retd.) as the Last Basic Pay drawn at the time of retirement minus Pension i.e., a fixed monthly amount shall be admissible as arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the period. There will be no annual increment/percentage increase during the period. The remuneration will be paid from the funds of The Cooperative Store Ltd., Super Bazar, New Delhi.
- Now, therefore, after careful consideration of the facts, I, Vijay Kumar, Central Registrar of 4. Cooperative Societies, in exercise of powers conferred under Section 89 (1) of the MSCS Act, 2002, appoint Shri Dinesh Kumar Sonker, Director (Cooperation) (Retd.), DoCA as Official Liquidator, The Cooperative Store Ltd. (Super Bazar), New Delhi w.e.f. 01.01.2022 till further orders. The remuneration of the Liquidator shall be the Last Basic Pay drawn at the time of retirement minus Pension i.e., a fixed monthly amount shall be admissible as arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration shall remain unchanged for the period. There will be no annual increment/percentage increase during the period. The remuneration will be paid from the funds of The Cooperative Store Ltd., Super Bazar, New Delhi.
