Therefore, it has been decided to initiate winding up of the Society under the provisions of MSCS Act, 2002 and Rules made thereunder. Any objections to the same may be brought to the notice of the Central Registrar of Cooperative Societies within 15 days from the date of uploading this notice on the office website i.e. www.mscs.dac.gov.in failing which, it will be presumed that the Society has nothing to say and further action to wind up the Society would be initiated as per the provisions of MSCS Act and rules made thereunder.
