ORDER

(Under Section 86 of the Multi-State Cooperative Societies Act, 2002)

"Rubi Credit Cooperative Society Ltd, Shakun, Narsinghpura Faisagar Road, Ajmer, Rajasthan-305001" (MSCS/CR/407/2011) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies Act, 2002 and Rules made thereunder (hereinafter referred as Act).

2) The Registrar of Cooperative Societies, Government of Rajasthan vide letter No. 15(19) (10) Savira/ Bank-1/Rubi-MSCS/2022 dated 31.10.2022 forwarded an inspection report of Society conducted by the Deputy Registrar, Cooperative Societies, Ajmer, under Section 108 of the Act and reported that Society is neither functioning at its registered address nor at its temporary address. Society's record is with two police stations and previous officials of the Society and newly elected Board of Directors have resigned. Besides this, the Society has not submitted its Annual returns after financial year 2017-18.

3) Therefore, to provide an opportunity to the Society, an advertisement dated 12.12.2022 for seeking objections to initiate winding up of the Society within 15 days from the date of the publication was issued. Notice was published on this office's website - <https://mcs.dac.gov.in> and sent to Society's registered address via speed post. But no reply has been received in this context. Since, opportunity has been given to the Society and no response in this regard was received from the Society, therefore, it appears that the Society is not functioning at its registered address in accordance with the provisions of the MSCS Act and Rules. Therefore, it has been decided to initiate winding up of the Society under the provision of the Act and Rules made thereunder.

4) The Registrar of Cooperative Societies, Govt. of Rajasthan, Jaipur vide letter No. 15(19)savira/Bank-1/avsayanadheen/ mscs/2021 dated 07.09.2021 has already provided a list of Officers by Post/designation of the Cooperative Department, Government of Rajasthan for appointment as liquidator in the multi-State cooperative societies.

5) Now, therefore, after careful consideration of the facts I, Vijay Kumar, Central Registrar of Cooperative Societies in exercise of the powers conferred under Section 86 of the Act, order winding up of "Rubi Credit Cooperative

Society Ltd, Shakun, Narsinghpura Faisagar Road, Ajmer, Rajasthan-305001* and hereby appoint Deputy Registrar, Cooperative Societies, Ajmer, Rajasthan as liquidator of the Society under the provisions of Section 89 (1) of the Act to take necessary further action as per the provisions of Multi-State Cooperative Societies Act, 2002 and Rules made thereunder.

7) The liquidator shall submit the status report showing the progress made in liquidation of the Society on quarterly basis to this office.
