**SHOW CAUSE NOTICE**

Pride Multi State Credit Cooperative Society Ltd., Boinchigram, Pashimpura, District-Hoogly - 712135, West Bengal (Registration No. MSCS/CR/797/2013) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules made thereunder (hereinafter referred as Act).

2. A complaint regarding forged signature of the auditor after his demise on the Annual Returns for the financial years 2016-17 & 2017-18 of the Society was received in this office. Therefore, a personal hearing of the Society was held on 05.01.2022 through video conference before Central Registrar of Cooperative Societies (CRCS). After examination of the reply furnished by the Society, the same was not found satisfactory as it is a matter of fact that the annual returns of the Society were filed under name and signature of a dead person as auditor. Further, the Registrar of Cooperative Societies, Govt. of West Bengal conducted an inspection of the Society u/s 108 of the Act and vide letter dated 16.06.2022, submitted that the Society is not functioning at its registered address. Also, several other irregularities were also noticed e.g. holding the election of the Board/ Chairman of the Society in two consecutive years in the AGM held on 15.10.2016 and 18.11.2017 without any reason, not conducting annual general meetings within the prescribed time limit i.e. within six months of closure of the accounting year as per the provisions of the Act and Rules, electing the Chief Executive of the Society instead of appointing CEO as per the provision of the Act, etc.

3. Besides above, the Society has not submitted its Annual Returns mandatory under the provisions of Section 120 of the Act to this Office since the financial year 2019-20. The Society also shifted its office to Kerala without approval for amendment of its bye-laws by CRCS.

4. Therefore, it appears that the Society is not functioning as per the provisions of the Act, Rules, approved bye-laws and Cooperative Principles.

5. Therefore, the Pride Multi State Credit Cooperative Society Ltd. is directed to explain within 15 days from the date of issue of the notice why winding up process of the Society should not be initiated under the provisions of the Act, failing which it will be presumed that the Society has nothing to say and accordingly action would be initiated under the provisions of the Act and Rules.
