Notice

Chief Promoter of **National Cooperative Development And Advisory Council Ltd., A-35, Priyadarshini Vihar, Laxmi Nagar, Delhi-92** has submitted a proposal for registration under the provisions of MSCS Act, 2002.

On scrutiny, following deficiencies have been found in the proposal:-

1. The name of the Society is misleading, it gives an impression as it is being patronized by the Govt. of India and the word 'National' gives an impression that it is a pan-India society.
2. Resolutions have not been enclosed with the application.
3. Definition of the Society is not mentioned in bye-law no.2.
4. Bye-law no. 3.15.1 is vague as shares can be transferred to members only.
5. Instead of submitting the Bank Certificate in original, the Society has enclosed its photocopy.
6. Some of the ID proofs attached by the society are not clearly visible.
7. Bye-law nos. 3.17.3, 7, 7.1 & 7.2 relates to credit for which the **following documents have been made mandatory for the proposed credit societies to submit along with their proposal of registration, which are not enclosed by the Society:-**
 - A. No objection Certificate from the Registrar of Cooperative Societies of the States/U.T. where the area of operation of the society extends.
 - B. A certificate to the effect that the credential of the Chief Promoter/Promoters members have been verified by the Registrar of Cooperative Societies of the States where the head office is proposed to be located.
8. Usage of the word "Council" in the name of the society is not appropriate.
9. Bye Law No. 5.1 is not consistent with Section 41 of the MSCS Act, 2002.
10. Bye Law No. 5.18 is against the principles of democratic management of Cooperatives.
11. Bye Law No. 10.1 is not consistent with the winding up provisions of the MSCS Act, 2002.
12. Bye Law No. 11.1.2.1 & 11.1.2.2 is vague.
13. Bye Law No. 5.2.5 is vague.
14. The objects mentioned in the bye laws do not indicate the services which will be offered to the members.
15. The procedure of amendment mentioned in bye law No. 8.1 is not consistent with the provisions mentioned in the MSCS Act, 2002.

In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the proposed society in the name of **National Cooperative Development And Advisory Council Ltd., A-35, Priyadarshini Vihar, Laxmi Nagar, Delhi-92** under the Multi-State Cooperative Society Act. 2002 and the rules made there under shall not be refused. The Chief Promoter of the society or in his absence any promoter member authorised by him is called upon to appear before the Central Registrar of Cooperative Societies on **18/02/2016 at 9:00 A.M. in Room No. 224, Krishi Bhawan, New Delhi.**

If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly appropriate order shall be passed, ex-parte.
