## Notice

Chief Promoter of Swami Vivekananda Multi State Multipurpose Cooperative Society Ltd., AD-222, Sector-I Saltlake, Kolkata-700064 has submitted a proposal for registration under the provisions of MSCS Act, 2002.

On scrutiny, following deficiencies have been found in the proposal:-

- 1. It has been found that the Society with the same name already exists.
- 2. Definition of "person" is not consistent with Section 25 of MSCS Act, 2002.
- 3. The word "At Least" is required to be deleted from the bye law no. 11(i).
- 4. Bye-law no. 16 is vague as shares can be transferred to members only.
- 5. Bye Law. No. 21(c) relates to credit.
- 6. Bye law no. 22 is not consistent with the Section 67 of the MSCS Act, 2002.
- 7. Bye-law No. 32 is not framed properly regarding constitution of the Board of Directors. The words "not more than 21" is required to be deleted in this bye-law.
- 8. As some of the objects and functions of the society relates to credit/multi-purpose, the following documents have been made mandatory for the proposed credit/multi-purpose society to submit along with their proposal of registration, which are not enclosed by the Society:-
  - A. No objection Certificate from the Registrar of Cooperative Societies of the States/U.T. where the area of operation of the society extends.
  - B. A certificate to the effect that the credential of the Chief Promoter/Promoters members have been verified by the Registrar of Cooperative Societies of the States where the head office is proposed to be located.
- Resolution submitted by the Society is not consistent to Rule 3(4) of the MSCS Rules, 2002.
- 10. Information of interim board/list of Promoters have not been given by the Society.
- 11. The expression "delegates of the body" is required to be substituted by the expression "members of general body" in bye law no. 31(i).
- 12. The word "additional" is required to be deleted in bye-law no. 43(iii).

In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the proposed society in the name of Swami Vivekananda Multi State Multipurpose Cooperative Society Ltd., AD-222, Sector-I Saltlake, Kolkata-700064 under the Multi-State Cooperative Society Act. 2002 and the rules made there under shall not be refused. The Chief Promoter of the society or in his absence any promoter member authorised by him is called upon to appear before the Central Registrar of Cooperative Societies on 22/02/2016 at 9:30 A.M. in Room No. 224, Krishi Bhawan, New Delhi.

If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly appropriate order shall be passed, ex-parte.
