Notice

Chief Promoter, **Anmol Agro Multi-State Co-operative Society Limited, Anmol Tower, 171/A-2, Opposite Mahatma Fule School, Cement Road, Vaishali Nagar, Nagpur, Maharashtra-440017** has submitted a proposal for registration of a multi-State cooperative society under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002. On scrutiny, the following deficiencies have been observed in the proposal :-


- i) The reasons given for registration of the society under MSCS Act, 2002 in Form No. 1 appear to be not satisfactory and the society can be registered under the State Act to achieve the objectives.
- ii) The objectives and functions provided in bye-law No. 5 appears to be not objectives of the cooperative society and whereas, the same are some of the objectives of the country to uplift the farmers in the country as a whole.
- iii) In bye-law No. 11 relating to procedure for obtaining ordinary membership and its disposal, the proviso as required u/s 25(4) has not been provided.
- iv) Bye-law No. 21(1) relating to liability of past member and estate of the deceased member is not consistent with the provision of section 37(1) of the Act.
- v) The provision made in bye-law No. 34(f) is not required to be provided in the bye-law since the same is subject matter of the Central Government.
- vi) Bye-law No. 56(i)(c) is not framed properly in consonance with the provision of section 63 of the Act.
- vii) Bye-law No. 61(a) relating to audit is not consistent with the provision of section 70 of the Act. Further, in this bye-law, the provision relating to remuneration of auditors has not been provided as required under the above provision of the Act.
- viii) The limitation periods in disputes is repeating in two bye-laws in Serial No. 67 & 68
- ix) The bank certificate furnished along with the application is old and the same is required to be furnished latest before submitting the proposal to the authority.
- x) Project report is not satisfactory. It is the photocopies taken from some other project and not supported by facts and figures, based on the objectives of the society.

- xi) In the membership list of Maharashtra, full addresses of the members have not been provided in many places as required under Form No. 1. Further, some of the members have provided 50 times more share capital than the other members for the reason has not been mentioned in the proposal.
- xii) In the membership list of Chhattisgarh, full addresses of the members have not been provided in some places as required under Form No. 1. Further, some of the members have provided 86 times more than the share capital than the other members for the reason has not been mentioned in the proposal.

2. In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the above proposed society in the name of **Anmol Agro Multi-State Co-operative Society Limited, Anmol Tower, 171/A-2, Opposite Mahatma Fule School, Cement Road, Vaishali Nagar, Nagpur, Maharashtra-440017** under the Multi-State Cooperative Societies Act, 2002 and the rules made thereunder shall not be refused. The Chief promoter of the society or in his absence any promoter member authorized by him is called upon to appear before the Central Registrar of Cooperative Societies on **3rd February, 2016 at 9.15 A.M. in Room No. 224, Krishi Bhavan, New Delhi.**

3. If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly, appropriate order shall be passed as ex-parte.
