Chief Promoter, Best India Credit Co-operative Society Limited, H-15, Chitranjan Marg, C-Scheme, Jaipur-302001, has submitted a proposal for registration of a multi-State cooperative society under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002. On scrutiny, the following deficiencies have been observed in the proposal:-

- All the resolutions enclosed along with the proposal are photocopies and also very old and not updated before the submission of the proposal.
- b) Instead of submitting the bank certificate in original, the society has enclosed its photocopy. Further, the bank certificate was issued by the bank during December 2012 and whereas, latest certificate has to be furnished along with the proposal.
- c) Definition of the society is not mentioned in bye-law No. 2.
- d) Bye-law No. 20(i) is vague as shares can be transferred to members only.
- e) Bye-law No. 34 is repetitive as it is already included in bye-law No. 32 and the clause of casual vacancy is not consistent with the MSCS Act, 2002.
- f) Society has submitted incomplete ID proofs of its members and also some of the ID proofs are not visible.
- g) Membership list has not been attested by the Chief promoter.
- h) It is observed that the RCS, Haryana has given NOC particularly for Narnaul District, whereas it is found that in the membership list of Haryana, out of 53 members, only 43 members belong to Narnaul. Hence the minimum requirement of at least 50 members from each State is not fulfilled.
- i) In the membership list of Rajasthan, many persons belonging to the student community have been admitted as members and in some places, it appears that few persons have signed. Further, in the membership list of both the States of Rajasthan and Haryana, in many places full addresses of members have not been provided as required under Form No. 1. Further, the membership list of Haryana may be taken from the societies already listed in the State/Centre.
- j) The NOC issued by the Haryana Government is very old i.e. issued during August 2014 and whereas, new NOC is required to be submitted along with the proposal.

- k) The NOC issued by the Rajasthan Government is very old i.e. issued during May 2014 and whereas, new NOC is required to be submitted along with the proposal.
- 1) Project report is not satisfactory. It is the photocopy of the project report which has been taken from other sources and not prepared based on the requirement supported by facts and figures.
- In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the above proposed society in the name of Best India Credit Co-operative Society Limited, H-15, Chitranjan Marg, C-Scheme, Jaipur-302001, under the Multi-State Cooperative Societies Act, 2002 and the rules made thereunder shall not be refused. The Chief promoter of the society or in his absence any promoter member authorized by him is called upon to appear before the Central Registrar of Cooperative Societies on 3rd February, 2016 at 9.00 A.M. in Room No. 224, Krishi Bhavan, New Delhi.
- If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly, appropriate order shall be passed as ex-parte.
