Chief Promoter, Indraprastha Multi State Cooperative Group Housing Society Limited, P-4, Vijay Vihar, Uttam Nagar, New Delhi – 110059 has submitted a proposal for registration of a multi-State cooperative society under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002. On scrutiny, following deficiencies have been observed in the proposal:-

- i) The objectives are vast in Form No. 1 and in bye-law No. 5. At the time of registration, the objectives are to be limited to certain extent since the bye laws are amendable as the need arises from time to time based on the requirement.
- ii) In Form No. 1 (Column No. (I)(b)), number of persons from each State who have signed the application has not been provided.
- iii) In bye-law No. 12 relating to application for membership and its disposal, the proviso as required u/s 25(4) has not been provided.
- iv) Bye-law No. 25(1) relating to liability of past member and estate of the deceased member is not consistent with the provision of section 37(1) of the Act.
- v) The provision made in bye-law No. 37(2)(m) should be listed at the end of this bye-law.
- vi) In bye-law No. 48 relating to powers and functions of Chief Executive, the provision as required u/s 52(k) has not been provided.
- vii) Bye-law No. 50(c) is not framed properly in consonance with the provision of section 63 of the Act.
- viii) In bye-law No. 51(d), the name of the institution on which investment of funds to be made, has not been specified.
- ix) Bye-law No. 56 relating to audit is not framed properly in consonance with the provision of section 70 of the Act.
- x) Project report is not satisfactory. It has not been prepared based on the objectives supported by facts and figures. Further, it appears that the same has been copied from some other project report.
- xi) In the membership list of Haryana, it appears that some persons have signed in few places. Further, in many places, full addresses of members have not been provided as required under Form 1 of the Act.

- 2. In view of above deficiencies, you are hereby called upon to show cause as to why registration of the above proposed society in the name of Indraprastha Multi State Cooperative Group Housing Society Limited, P-4, Vijay Vihar, Uttam Nagar, New Delhi 110059 under the Multi-State Cooperative Societies Act, 2002 and the rules made thereunder shall not be refused. The Chief promoter of the society or in his absence any promoter member authorized by him is called upon to appear before the Central Registrar of Cooperative Societies on 3rd February, 2016 at 9.30 A.M. in Room No. 224, Krishi Bhavan, New Delhi.
- 3. If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly, appropriate order shall be passed as ex-parte.
