Notice

Chief Promoter, Madheshwari Multi-State Co-operative Textiles Ltd., Nimgaon (T), Gat No. 146, A/p-Nimgaon(T), Tal. Madha, District Solapur, Maharashtra-413210 has submitted a proposal for registration of a multi-State cooperative society under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002. On scrutiny, the following deficiencies have been observed in the proposal:-

- i) The objectives are vast in Form No. 1 and in bye-law No. 5. At the time of registration, the objectives are to be limited to certain extent since the bye laws are amendable as the need arises from time to time based on the requirement.
- In Form No. 1 (Column No. (e)), reasons/necessity for registration of the society under MSCS Act, 2002 has not been provided. Further, with the objectives proposed, it can be registered under the State Act.
- iii) The project report is not satisfactory and the same are photocopies of some other project. The project report is not supported by facts and figures based on the objectives.
- iv) The credit balance in favour of the society is differing from the bank certificate and Form No. 1.
- v) In the membership lists of Maharashtra and Karnataka, it appears that some persons have signed in many places. Further, full addresses of the members have not been provided in many places as required under Form No. 1 and therefore, the genuineness of members cannot be ascertained.
- vi) Bye-law No. 8(1) relating to ordinary membership is not in consonance with the provision of section 25(1)(a) of the Act.
- vii) In bye-law No. 12 relating to membership and its disposal, the proviso as required u/s 25(4) has not been provided.
- viii) Bye-law No. 25(1) is not consistent with the provision of section 37(1) of the Act.
- ix) Bye-law No. 31(4) is not consistent with the provision of Election Rule 1(f) of Election Schedule annexed with MSCS Rule, 2002.
- x) Bye-law No. 36(b)(ii) is not framed properly.
- xi) Bye-law No. 44 is not serialled properly. Further, the provision made in this bye-law is in contravention to the provision of section 44(2) of the Act.

- 2. In view of the above deficiencies, you are hereby called upon to show cause as to why registration of the above proposed society in the name of Madheshwari Multi-State Co-operative Textiles Ltd., Nimgaon (T), Gat No. 146, A/p-Nimgaon(T), Tal. Madha, District Solapur, Maharashtra-413210 under the Multi-State Cooperative Societies Act, 2002 and the rules made thereunder shall not be refused. The Chief promoter of the society or in his absence any promoter member authorized by him is called upon to appear before the Central Registrar of Cooperative Societies on 3rd February, 2016 at 9.30 A.M. in Room No. 224, Krishi Bhavan, New Delhi.
- 3. If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly, appropriate order shall be passed as ex-parte.
