Notice

Chief Promoter of **Purbanchal Tourism Development Cooperative Society Ltd., 29 Sonkuchi, Bye Lane No. 3, Beharbari, Guwahati-781029, Assam** has submitted a proposal for registration under the provisions of MSCS Act, 2002.


On scrutiny, following deficiencies have been found in the proposal:-

1. It has been found that the Society with the similar name already exists.
2. Resolution submitted by the Society is not consistent to Rule 3(5) of the MSCS Rules, 2002.
3. Definition of the Society is not mentioned in bye-law no.2.
4. Bye Law No. 20(iii) relates to credit for which the **following documents have been made mandatory for the proposed credit societies to submit along with their proposal of registration, which are not enclosed by the Society:-**
 - A. No objection Certificate from the Registrar of Cooperative Societies of the States/U.T. where the area of operation of the society extends.
 - B. A certificate to the effect that the credential of the Chief Promoter/Promoters members have been verified by the Registrar of Cooperative Societies of the States where the head office is proposed to be located.
5. Bye Law No. 21 is not consistent with the Section 67 of the MSCS Act, 2002.
6. Bye Law No. 23 is not consistent with Rule 13(1) of the MSCS Rules, 2002.
7. ID proofs submitted by the Society are not clear.

In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the proposed society in the name of **Purbanchal Tourism Development Cooperative Society Ltd., 29 Sonkuchi, Bye Lane No. 3, Beharbari, Guwahati-781029, Assam** under the Multi-State Cooperative Society Act, 2002 and the rules made there under shall not be refused. The Chief Promoter of the society or in his absence any promoter member authorised by him is called upon to appear before the Central Registrar of Cooperative Societies on **15/01/2016 at 9:00 A.M. in Room No. 224, Krishi Bhawan, New Delhi.**

If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly appropriate order shall be passed, ex-parte.

This issues with the approval of Central Registrar of Cooperative Societies.
