Notice

Chief Promoter, Rokdoba Urban Agro Multi State Co-operative Society Ltd., Bank Colony, Behind Telephone Office, Chandra Prabha Niwas, Talegaon Road, Ahmedpur – 413515, Taluka: Latur, District: Latur, Maharashtra, has submitted a proposal for registration of a multi-State cooperative society under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002. On scrutiny, the following deficiencies have been observed in the proposal :-

- a) Before registration of the society, the Chief Promoter is using the nomenclature of President, whereas, it should be Chief Promoter.
- b) Reasons given in Point 1(e) of Form No. I for registration of the society under the MSCS Act, 2002 is not satisfactory.
- c) In Form I (column No. 1(i)), the number of persons from each State who has signed the application has not been provided.
- d) Point 2(a) relating to bank certificate is incomplete in Form No. I.
- e) Certificates required u/s 7(c) of MSCS Act, 2002 has not been found enclosed along with the application/proposal.
- f) Viability report has not been enclosed along with the application/proposal.
- g) Membership lists enclosed along with the proposal is not as per Form No. I (column No. 5) for both States. Further, it appears that few persons have signed in many places in the membership lists.
- h) The objectives of the society are vast in bye-law No. 5. At the time of registration, the objectives are to be limited to certain extent since the bye-laws are amendable as the need arises from time to time based on the requirement.
- i) In bye-law No. 7, it has been proposed to receive deposits and it is relating to credit activities for which NOC is required from the RCS where the society proposed as its area of operation.
- j) Bye-law No. 21(1) is not consistent with provision of section 37(1) of the MSCS Act, 2002.
- k) Bye-law No. 35(v) is not framed properly.
- l) In bye-law No. 47, the provision as required u/s 52(k) of the Act has not been provided.
- m) Bye-law No. 49(c) is not framed properly in consonance with the provision of section 63 of the Act.


n) In bye-law No. 50(d), the name of the institution on which investment to be made, has not been specified.

o) Bye-law No. 54 relating to audit is not in consonance with provision of section 70 of the Act.

2. In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the above proposed society in the name of **Rokdoba Urban Agro Multi State Co-operative Society Ltd., Bank Colony, Behind Telephone Office, Chandra Prabha Niwas, Talegaon Road, Ahmedpur – 413515, Taluka: Latur, District: Latur, Maharashtra**, under the Multi-State Cooperative Societies Act, 2002 and the rules made thereunder shall not be refused. The Chief promoter of the society or in his absence any promoter member authorized by him is called upon to appear before the Central Registrar of Cooperative Societies on **28/01/2016 at 9-00 A.M. in Room No. 224, Krishi Bhavan, New Delhi.**

3. If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly, appropriate order shall be passed as ex-parte.
