## Notice

Chief Promoter, SG Multi State Agro Purpose Co-operative Society Limited (Smart Gold), Dongare Bhawan, Lugharwara, In front of Durga Mandir, PO Bijhawara, Teh. Seoni, District Seoni, Madhya Pradesh – 460068 has submitted a proposal for registration of a multi-State cooperative society under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002. On scrutiny, the following deficiencies have been observed in the proposal :-

- i) The objectives proposed in Form No. I and in bye-law No. 5 are vast. Some of the objectives are pertain to federation. At the time of registration, the objectives are to be limited to certain extent since the bye-laws are amendable as the need arises from time to time based on the requirement.
- ii) In bye-law No. 11, the proviso as required u/s 25(4) has not been provided.
- Bye-law No. 23(1) is not consistent with the provision of section 37(1) of the MSCS Act, 2002.
- iv) Bye-law No. 34(v) is not framed properly.
- v) In bye-law No. 46, the provision as required u/s 52(k) of the Act has not been provided.
- vi) Bye-law No. 48(c) is not framed properly in consonance with provision of section 63 of the Act.
- vii) Bye-law No. 53(A) is not framed properly in consonance with provision of section 70 of the Act.
- viii) Project report is not satisfactory. The detailed break up for income & expenditure has not been provided. Further, the project report is not supported by facts and figures which have been narrated in the viability report.
- ix) Full address of the members in the membership lists of Madhya Pradesh & Chhattisgarh are not provided as required under Form I, Column 5. Further, some of the signatures appear to be signed by a few persons in the membership list.

2. In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the above proposed society in the name of SG Multi State Agro Purpose Co-operative Society Limited (Smart Gold), Dongare Bhawan, Lugharwara, In front of Durga Mandir, PO Bijhawara, Teh. Seoni, District Seoni, Madhya Pradesh – 460068 under the Multi-State Cooperative Societies Act, 2002 and the rules made thereunder shall not be refused. The Chief promoter of the society or in his absence any promoter member authorized by him is called upon to appear before the Central Registrar of Cooperative Societies on 15000 at 9-0000 A.M. in Room No. 224, Krishi Bhavan, New Delhi.

3. If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly, appropriate order shall be passed as ex-parte.
