Notice

Chief Promoter, **Yashwee Multi State Housing Co-operative Society Limited, E-40, Kashi Ram Nagar, Near Gautam Budham Park, Moradabad – 244001, Uttar Pradesh**, has submitted a proposal for registration of a multi-State cooperative society under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002. On scrutiny, the following deficiencies have been observed in the proposal :-


- i) In bye-law No. 6(vii), the society proposed to collect deposits from members for which NOC is required from the area of operation of the society where the society proposed as area of operation.
- ii) The main objective of the society is to acquire land, develop and construct residential houses/flats to the ordinary individual members whereas, in bye-law No. 10, the multi-State cooperative societies, cooperative societies, Central/State Government, NCDC and other institutions have been proposed as ordinary members.
- iii) In bye-law No. 12, the proviso as required u/s 25(4) has not been provided.
- iv) Bye-law No. 25(1) is not consistent with provision of section 37(1) of MSCS Act, 2002.
- v) Bye-law No. 50(c) is not framed properly.
- vi) In bye-law No. 51(d), name of the institution for investment of funds has not been specified.
- vii) In the membership list of UP and Uttarakhand, in many places proper addresses of members have not been provided. Further, it appears that few persons have signed in some places.
- viii) The project report is not satisfactory.

2. In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the above proposed society in the name of **Yashwee Multi State Housing Co-operative Society Limited, E-40, Kashi Ram Nagar, Near Gautam Budham Park, Moradabad – 244001, Uttar Pradesh**, under the Multi-State Cooperative Societies Act, 2002 and the rules made thereunder shall not be refused. The Chief promoter of the society or in his absence any promoter member authorized by him is called upon to appear before the Central Registrar of Cooperative Societies on 15/01/2016 at 9-30 A.M. in Room No. 224, Krishi Bhavan, New Delhi.

3. If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly, appropriate ~~order~~ shall be passed as ex-parte.
