Notice

Chief Promoter of Kanniyakumari Multi State & Multi-purpose Cooperative Society Ltd. (KMMCS), 33, Asoke Avenue, Kolkata-700040, West Bengal has submitted a proposal for registration under the provisions of MSCS Act, 2002.

On scrutiny, following deficiencies have been found in the proposal:-

- 1. Instead of submitting the Bank Certificate in original, the Society has enclosed a copy of a pay-in-slip.
- 2. Certificates stipulated under Section 7(b,c, d) of MSCS Act, 2002 have not been enclosed with the application.
- 3. Membership list submitted by the society has not been attested by the Chief Promoter:
- 4. Each page of the Bye laws needs to be signed.
- 5. The objectives of the society are very vast & lack cohesion.
- 6. ID proofs have not been attested by the Chief Promoter.
- 7. Viability report has not been enclosed with the application.
- 8. Bye law No.4[i(13&25)], 19(iii) relates to credit.
- 9. Bye law No. 25 (a&b) is not consistent with Rule 15 of the MSCS Rules, 2002.
- 10. Since the Society is a Multi-purpose/ Credit Society, the following documents have been made mandatory for the proposed credit/ Multi-purpose society to submit along with their proposal of registration, which are not enclosed by the Society:-
 - A. No objection Certificate from the Registrar of Cooperative Societies of the States/U.T. where the area of operation of the society extends.
 - B. A certificate to the effect that the credential of the Chief Promoter/Promoters members have been verified by the Registrar of Cooperative Societies of the States where the head office is proposed to be located.
- 11. Abbreviated name of some other society has been mentioned in bye-law No. 4(i)(16).

- 12. Bye-law no. 5(a)(vi) is not consistent with Section 25 of the MSCS Act, 2002. Further the Society has proposed that under bye-law no. 5(a)(i), a National Cooperative Federation can be admitted as the member of the society. It is not clear, that how a primary cooperative Society will admit a National Cooperative Federation as a member.
- 13. Bye-law No. 7 is not consistent with the provision of section 29 of the MSCS as provision relating to minimum level of services as required u/s 29(b) has not been specified.
- 14. Bye law No. 27 does not specify that the board of directors shall be elected by the General Body & bye-law no. 27(iii) is not consistent with Section 41 of the MSCS Act, 2002.

In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the proposed society in the name of Kanniyakumari Multi State & Multipurpose Cooperative Society Ltd. (KMMCS), 33, Asoke Avenue, Kolkata-700040, West Bengal under the Multi-State Cooperative Society Act. 2002 and the rules made there under shall not be refused. The Chief Promoter of the society or in his absence any promoter member authorised by him is called upon to appear before the Central Registrar of Cooperative Societies on 28/10/2016 at 9:00 A.M. in Room No. 224, Krishi Bhawan, New Delhi.

If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly appropriate order shall be passed, ex-parte.
