Chief Promoter of Skylight Multi State Fisheries Cooperative Society Ltd., Old Overbridge, Rama Path Hotel Tribhuvan, Ranchi, Jharkhand has submitted a proposal for registration under the provisions of MSCS Act, 2002.

On scrutiny, following deficiencies have been found in the proposal:-

- 1. The Society has shown itself as a Multi State Society registered under Multi State Cooperative Society Act in 2002, which is not true. Thus the Society does not appear to be genuine.
- 2. The documents submitted by the society are not as per Section 11 of the MSCS Act, 2002.
- 3. Form -1 has not been submitted by the Society.
- 4. Section 7(c) Certificate has not been enclosed with the application.
- 5. Resolution has not been enclosed with the proposal.
- 6. Viability report has not been attached with the application.
- 7. Bank Certificate has not been attached with the application.
- 8. Membership list has not been submitted by the Society and also the Society does not fulfill the minimum requirement of atleast 50 members from each State.
- The bye-laws submitted by the Society are not as per MSCS Act, 2002 and also the Society has submitted 4 copies of the model bye-laws with some remarks such as "-Do"-
- 10. Bye-law No. 1(c) is not consistent to MSCS Act, 2002.
- 11. Bye-law No. 1(d) is not consistent to Section 11(3) of MSCS Act, 2002.
- 12. Bye-law No. 2(a) is not clearly defined.
- 13. Bye-law No. 2(e) is not required to be incorporated.
- 14. The objectives mentioned in bye-law No.3 are too generalized as it does not indicate that how the Society holds the necessary prospects of becoming a viable unit.
- 15. Bye-law No. 4(a) is not in consonance with the provision of section 26 of the MSCS Act, 2002.
- 16. Bye-law No. 5 is not in consonance with the provision of section 29 of the MSCS Act, 2002.
- 17. In bye-law No. 6, the sources of funding are not known.

- 18. Bye law Nos. 7, 8 & 9 are not as per MSCS Act, 2002.
- 19. Composition of Board has not been incorporated in bye-law no. 10.
- 20. Bye-law No. 11 is not required and needs to be deleted.
- 21. ID No. that has been mentioned in the ID proofs of members does not indicate which ID card has been taken as a reference.

In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the proposed society in the name of Skylight Multi State Fisheries Cooperative Society Ltd., Old Overbridge, Rama Path Hotel Tribhuvan, Ranchi, Jharkhand under the Multi-State Cooperative Society Act. 2002 and the rules made there under shall not be refused. The Chief Promoter of the society or in his absence any promoter member authorised by him is called upon to appear before the Central Registrar of Cooperative Societies on 22/11/2016 at 9:00 A.M. in Room No. 224, Krishi Bhawan, New Delhi.

If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly appropriate order shall be passed, ex-parte.
