## Notice

Chief Promoter of Uttar Pradesh Rajya Sahkari Nirman Evam Vikas Division Ltd., (UPSD), 1<sup>st</sup> Floor, B-4, Nehru Vihar, Kalyanpur, Lucknow (U.P) has submitted a proposal for registration under the provisions of MSCS Act, 2002.

On scrutiny, following deficiencies have been found in the proposal:-

- 1. The name of the Society is not framed properly as it includes the word "Division" which is required to be deleted.
- 2. Bye-law No 15 is not consistent with section 29 of the MSCS Act 2002 as provision of minimum level of services has not been incorporated.
- 3. Information of interim board/ list of Promoters have not been given by the Society.
- 4. ID proofs are required to be submitted along with the proposal.
- 5. In Bye-law No. 5, the objectives are vast. Many Multifarious/ multi purpose activities have been proposed for which "NOC" is required from the concerned Registrar of Cooperative Societies, where the Society proposed as area of operation as per Rule 3(1)(g) of MSCS Rules, 2002.
- 6. Bye law No. 7 is not framed properly in consonance with the provision of Section 67 of the MSCS Act, 2002.
- 7. Bye-law No. 28 & 31 is not serially numbered.
- 8. Bye law No. 30(c) is not framed properly in consonance with the provision of Rule 1(f) of the election schedule annexed with the MSCS Rule, 2002.
- 9. The heading of the bye-law No. 36 is not framed properly.
- 10. The provision made at the end of the bye-law No. 35 to be made as separate bye-law.
- 11. The proposed society is a Multi State Cooperative Society and where as the name proposed is "Uttar Pradesh Rajya Sahkari Nirman Evam Vikas Division Ltd."
- 12. The proposed society is a construction society and whereas in bye-law No. 10, apart from individuals, Multi State Cooperative Society, Central Govt., State Govt., NCDC, Corporations, Companies have been proposed as members.

- 13. The membership list is not framed or prepared properly. Further full addresses of members have not been given as required under Form No. 1 of the Act. Further on a single page 28 members have been signed and therefore genuiness of the members cannot be ascertained.
- 14. Project report is a photocopy and on the same the Chief Promoter has signed. Further in the project report, it has been proposed to receive deposits from members for which "NOC" is required.

In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the proposed society in the name of Uttar Pradesh Rajya Sahkari Nirman Evam Vikas Division Ltd., (UPSD), 1<sup>st</sup> Floor, B-4, Nehru Vihar, Kalyanpur, Lucknow (U.P) under the Multi-State Cooperative Society Act. 2002 and the rules made there under shall not be refused. The Chief Promoter of the society or in his absence any promoter member authorised by him is called upon to appear before the Central Registrar of Cooperative Societies on 28/10/2016 at 9:30 A.M. in Room No. 224, Krishi Bhawan, New Delhi.

If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly appropriate order shall be passed, ex-parte.
