Notice

Chief Promoter of SSRS Housing Cooperative Society Ltd., F-155/3, Block-F, Abdul Fazal Enclave Part-II, Shahin Bagh, Okhla, New Delhi-110025 (Delhi) has submitted a proposal for registration under the provisions of MSCS Act, 2002.

On scrutiny, following deficiencies have been found in the proposal:-

- 1. It is not clear that the abbreviation SSRS in the name of the society stands for what?
- 2. It has been observed that in Form No. 1(C), Resolution No. 2 and the bye-law No.3, the proposed area of operation of the Society is confined to the States of Bihar, Chandigarh, Delhi, Haryana, Himachal Pradesh, Jharkhand, Punjab, Rajasthan, Uttar Pradesh and Uttarakhand. Whereas Vide Order dated 26.3.2014, it has been mandated that initial registration shall be granted for two states only.
- 3. Instead of submitting the Bank Certificate in original, the Society has enclosed a copy of the Pass Book.
- 4. Resolution No. 4 relating to opening of bank account is incomplete.
- 5. Membership list submitted by the Society is not in the format annexed to MSCS Rules, 2002.
- 6. ID proofs attested by the Chief Promoter have not been submitted by the Society.
- 7. Definition of "persons" has not been included in bye-law No. 4.
- 8. The objectives are vast in Form No. 1 as well as in bye-law No. 5. It should be restricted to minimum level at the time of registration since bye-laws are amendable as and when required.
- 9. The mandatory document of membership lists duly signed by the promoter members are not enclosed along with the application form as required under Form No. 1, column No. 5.
- 10. Project report is not satisfactory. It is not prepared based on real time basis which is suitable to cooperative and achievable by the society. Further, the profit appropriation as required u/s 63 of the Act has not been provided.
- 11. The proposed authorized share capital is very high. At the time of registration, it should be restricted to the minimum level since the same are amendable by making bye-law amendments as per the requirement from time to time.

In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the proposed society in the name of SSRS Housing Cooperative Society Ltd., F-155/3, Block-F, Abdul Fazal Enclave Part-II, Shahin Bagh, Okhla, New Delhi-110025 (Delhi) under the Multi-State Cooperative Society Act. 2002 and the rules made there under shall not be refused. The Chief Promoter of the society or in his absence any promoter member authorised by him is called upon to appear before the Central Registrar of Cooperative Societies on 5/10/2016 at 9:15 A.M. in Room No. 224, Krishi Bhawan, New Delhi.

If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly appropriate order shall be passed, ex-parte.
