Notice

Chief Promoter of A Saharayn Agro Cooperative Society Ltd., Barhmharshi Lane, Old Arvind Mahila College Road, Kadamkaum, Patna-800003 (Bihar) has submitted a proposal for registration under the provisions of MSCS Act, 2002.

On scrutiny, following deficiencies have been found in the proposal:-

- It has been observed that in Form No. 1(C), Resolution No. 2 and the bye-law No.3, the proposed area of operation of the Society is confined to the States of Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh, Maharashtra, Orissa, Rajasthan, Uttar Pradesh, Uttarakhand and West Bengal. Whereas Vide Order dated 26.3.2014, it has been mandated that initial registration shall be granted for two states only.
- 2. Instead of submitting a Bank Certificate in original, the Society has submitted a copy of an account statement which is not clearly visible and in which it is also not clear who is the issuing authority?
- 3. Resolution No. 4 relating to opening of bank account is incomplete.
- Membership list submitted by the Society is not in the format annexed to MSCS Rules, 2002.
- 5. ID proofs attested by the Chief Promoter have not been submitted by the Society.
- 6. Definition of "persons" has not been included in bye-law No.4.
- The objectives are vast in Form-1 as well as in bye-laws No.5. It should be restricted to minimum level at the time of registration since bye laws are amendable as and when required.
- The mandatory document of membership list duly signed by the promoter members is not enclosed along with the application form as required under Form-1, column No. 5.
- Project report is not satisfactory. It is not prepared based on real time basis which is suitable to cooperative and achievable by the society. Further, the profit appropriation as required u/s 63 of the Act has not been provided.
- 10. The project report of Stara Agro Cooperative Society Limited, Vijaywada, Andhra Pradesh and the present project report are the same. Project proposals differ from each other from one State to another State.
- 11. The proposed authorized share capital is very high.

In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the proposed society in the name of A Saharayn Agro Cooperative Society Ltd., Barhmharshi Lane, Old Arvind Mahila College Road, Kadamkaum, Patna-800003 (Bihar) under the Multi-State Cooperative Society Act. 2002 and the rules made there under shall not be refused. The Chief Promoter of the society or in his absence any promoter member authorised by him is called upon to appear before the Central Registrar of Cooperative Societies on 5/10/2016 at 9:00 A.M. in Room No. 224, Krishi Bhawan, New Delhi.

If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly appropriate order shall be passed, ex-parte.
