Notice

Chief Promoter of **Suvarnakanti Urban Multi-State Cooperative Credit Society Ltd., 'Gurumauli Nivas' Anandsagar Society, Near Shani Mandir, Main Road Hudco, Nanded-431603 (M.S.)** has submitted a proposal for registration under the provisions of MSCS Act, 2002.

On scrutiny, following deficiencies have been found in the proposal:-

1. Bye-law no. 20(i) is vague as shares can be transferred to members only.
2. Important provisions like Winding up of Multi State Cooperative Society has not been included in the Bye laws.
3. Membership list submitted by the Society is not in the format annexed to MSCS Rules, 2002.
4. The proposed Society has submitted the list of only 11 members from the State of Maharashtra hence the minimum requirement of atleast 50 members from each state is not fulfilled.
5. The Society has submitted incomplete ID proofs of its members.
6. Since the Society is a Credit Society, the following documents have been made mandatory for the proposed credit society to submit along with their proposal of registration, which are not enclosed by the Society:-
  - A. No objection Certificate from the Registrar of Cooperative Societies of the States/U.T. where the area of operation of the society extends.
  - B. A certificate to the effect that the credential of the Chief Promoter/Promoters members have been verified by the Registrar of Cooperative Societies of the States where the head office is proposed to be located.

However, the Registrar of Cooperative Societies, Maharashtra has refused to grant NOC to the said Society vide their letter dated 8<sup>th</sup> July, 2016.

In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the proposed society in the name of **Suvarnakanti Urban Multi-State Cooperative Credit Society Ltd., 'Gurumauli Nivas' Anandsagar Society, Near Shani Mandir, Main Road Hudco, Nanded-431603 (M.S.)** under the Multi-State Cooperative Society Act, 2002 and the rules made there under shall not be refused. The Chief Promoter of the society or in his absence any promoter member authorised by him is called upon to appear before the Central Registrar of Cooperative Societies on 18/10/2016 at 9:00 A.M. in Room No. 224, Krishi Bhawan, New Delhi.

If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly appropriate order shall be passed, ex-parte.
