Notice

Chief Promoter, **Jai Shivray Agro Multi State Co-operative Society Limited, Shop No. 01, Muktabai Sanpat Phulore Niwas, At-Bhokarpada, Post Nere, Tal-Panvel, District Raigad, Maharashtra – 410206**, has submitted a proposal for registration of a multi-State cooperative society under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002. On scrutiny, the following deficiencies have been observed in the proposal :-


- i) Bank certificate showing the credit balance in favour of the society as required under rule 3(1)(c) of the Act has not been enclosed along with the application for registration.
- ii) The proposed objectives in bye-law No. 5 are vast. Further, the objectives proposed are not pertaining to a cooperative society and it appears it is the objectives of the government to achieve for the entire community of farmers.
- iii) Bye-law No. 8 is not framed properly.
- iv) The admission fee proposed in bye-law No. 11 is at higher side and the same to be less than the value of one share.
- v) In bye-law No. 11, the proviso as required u/s 25(4) of the MSCS Act, 2002 has not been provided.
- vi) The provision made in bye-law No. 18(A) is not required to be provided in this bye-law and the same has to be provided in some other appropriate place in bye-laws.
- vii) Bye-law No. 21(1) is not framed properly in consonance with the provision of section 37(1) of the MSCS Act, 2002.
- viii) Bye-law No. 34 relating to election of the members of the Board is not framed properly.
- ix) Bye-law No. 61(a) is not in consonance with provision of section 70 of the Act.
- x) The objectives given in the project report appears to be not reasonable to achieve by a cooperative society and the same is applicable to the government or big corporate.
- xi) Project report is not satisfactory. The source of income for the project has not been provided.

- xii) In the membership list of Maharashtra, some of the members particularly the members listed from S.No. 1-7 have paid maximum 56 times more than the ordinary members and reason for the same is not clear.
- xiii) In the membership list, in many places full address of members have not been provided as required under Form No. 1 (col.5) of the Act.

2. In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the above proposed society in the name of **Jai Shivray Agro Multi State Co-operative Society Limited, Shop No. 01, Muktabai Sanpat Phulore Niwas, At-Bhokarpada, Post Nere, Tal-Panvel, District Raigad, Maharashtra - 410206**, under the Multi-State Cooperative Societies Act, 2002 and the rules made thereunder shall not be refused. The Chief promoter of the society or in his absence any promoter member authorized by him is called upon to appear before the Central Registrar of Cooperative Societies on **30-12-2018** at **9-00 A.M.** in Room No. 224, Krishi Bhavan, New Delhi.

3. If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly, appropriate order shall be passed as ex-parte.
