Chief Promoter, Kalpvarsha Agro Multi State Co-operative Society Limited, 418/14, Satya Prakash CHS, Sector 04, Charkop Kandivali (West) Mumbai, Maharashtra-400067, has submitted a proposal for registration of a multi-State cooperative society under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002. On scrutiny, the following deficiencies have been observed in the proposal :-

- The objectives in bye-law No. 5 are vast. At the time of registration, the objectives are to be limited to certain extent, since the bye-laws are amendable as the need arises from time to time based on the requirement.
- The objectives in bye-law No. 5 are not achievable by the society and the same are some of the objectives of the government to uplift the entire farming community.
- iii) Bye-law No. 8 is not framed properly.
- iv) In bye-law No. 11, the proviso as required u/s 25(4) of the MSCS Act, 2002 has not been provided.
- v) Bye-law No. 21(1) is not consistent with the provision of section 37(1) of the MSCS Act, 2002.
- vi) The provision made in bye-law No. 34(f) is not required.
- vii) Bye-law No. 34(g) & (h) are not framed properly.
- viii) Bye-law Nos. 67(a) & 68 are the same provision and therefore, bye-law No. 67(a) is required to be deleted.
- ix) The bank certificate showing the credit balance in favour of the society has not been enclosed as required under rule 3(1)(c) of the MSCS Rule, 2002.
- x) The Project report is not satisfactory. The source of income for the project has not been provided without which viability of the society cannot be ascertained. Further, the project report appears to be copied from some other proposal submitted to the Central Registrar.
- xi) In the membership lists of Maharashtra & Gujarat, it appears that some people have signed in many places. Further, some members have contributed 57 times more than the share capital contributed by an individual promoter member, the reasons for which not substantiated.

2. In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the above proposed society in the name of Kalpvarsha Agro Multi State Co-operative Society Limited, 418/14, Satya Prakash CHS, Sector 04, Charkop Kandivali (West) Mumbai, Maharashtra-400067, under the Multi-State Cooperative Societies Act, 2002 and the rules made thereunder shall not be refused. The Chief promoter of the society or in his absence any promoter member authorized by him is called upon to appear before the Central Registrar of Cooperative Societies on $O(3^{-1})$ at $9 - O(3^{-1})$ A.M. in Room No. 224, Krishi Bhavan, New Delhi. $O(3^{-0}) - 2016$
