## Notice

Chief Promoter, Aakanksha Agtro Multi State Co-operative Society Limited, 704, 'D' Wing, Shri Saipark. L.B.S. Road, Casttle Mill Naka, Thane (W) 400601, Maharashtra, has submitted a proposal for registration of a multi-State cooperative society under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002. On scrutiny, the following deficiencies have been observed in the proposal :-
a) In the covering letter addressed to the Central Registrar, no date has been mentioned.
b) In the authority letter, the name of the person to whom authorized to submit the application and date has not been mentioned.
c) In Form No. 1, at column No. I(e), the reasons given for registration of the society under the MSCS Act, 2002 is not properly supported the same.
d) The objectives proposed in bye-law No. 5 are vast. At the time of registration, the objectives are to be limited to certain extent since the bye-laws are amendable as the need arises from time to time based on requirement.
e) Bye-law No. 21(1) is not framed properly in consonance with the provision of section 37(1) of the MSCS Act, 2002.
f) Bye-law No. $34(\mathrm{~g})$ is not in consonance with provision of rule 1(a) of the election schedule annexed with MSCS Rules, 2002.
g) Bye-law No. 61 relating of : in'it ' arcounts and auditor is not in consonance with provision of section 70 of the MSCS Ac:
h) In the proposed bye-law, the provisions which are required to be included as per section 10 of the MSCS Act, 2002 have not been included.
i) The project report is not satisfactory. The source of income for the project has not been defined. Further, the profit appropriation in the project report is not as per bye-law No. 56 proposed by the society. The detailed income and expenditure has not been provided.
j) In the certificates furnished along with the proposal were attested by the President and not by the Chief Promoter. There are two designations namely Chief Promoter and President have been used in many places.
k) A certificate from the bank stating the credit balance in favour of the proposed multi-state cooperative society has not been enclosed along with the proposal as required under rule 3(c) of the MSCS Rule, 2002.

1) In the membership list, in many places, proper addresses have not been given as required in Form No. 1 of the MSCS Act 2002. Further, in the membership list of Maharashtra \& Gujarat, it has been observed that few persons have signed in some places. The signatures of some of the members are differing from the membership list and in the identity proof.
2. In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the above proposed society in the name of Aakanksha Agtro Multi State Co-operative Society Limited, 704, 'D' Wing, Shri Saipark. L.B.S. Road, Casttle Mill Naka, Thane (W) 400601, Maharashtra, under the Multi-State Cooperative Societies Act, 2002 and the rules made thereunder shall not be refused. The Chief promoter of the society or in his absence any promoter member authorized by him is called upon to appear before the Central Registrar of Cooperative Societies on

3. If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly, appropriate order shall be passed as ex-parte.
