
On scrutiny, following deficiencies have been found in the proposal:-

1. In Form 1, number of persons from each State who have signed the application has not been indicated in Point 1(i).
2. Details of Society's address, Correspondence address, deposit of share capital, are not mentioned in the Resolutions.
3. Section 7(c) certificate has not been enclosed with the application.
4. Viability report has not been enclosed with the application.
5. Bye law no. 4 (P) relating to Cooperative year which mentions 151 of April should be replaced by 1st of April.
6. Bye-law no. 44 (a) is vague.
7. Name of some other Society has been mentioned in bye law no 4(i).

In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the proposed society in the name of **Jivan Vikas Urban Agro Multi State Cooperative Society Ltd., Dayaram Road, Khadhak Hanuman Chowk, Near Godavari High School, Wood Works Shop, Latur 413512 Taluka:Latur Dist: Latur (Maharashtra)** under the Multi-State Cooperative Society Act, 2002 and the rules made there under shall not be refused. The Chief Promoter of the society or in his absence any promoter member authorised by him is called upon to appear before the Central Registrar of Cooperative Societies on **28/10/2015 at 11:00 A.M. in Room No. 224, Krishi Bhawan, New Delhi.**

If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly appropriate order shall be passed, ex-parte.
