Notice

Chief Promoter, **Vishwajeet Agro Multi State Co-operative Society Limited, Srushti Niwas, At Post Khandke, Kaudgaon, Taluka Nagar, District-Ahmednagar-414001, Maharashtra**, has submitted a proposal for registration of a multi-State cooperative society under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002. On scrutiny, the following deficiencies have been observed in the proposal :-


- a) Before registration of the society, the Chief Promoter is using the nomenclature of President and it should be Chief Promoter.
- b) The objectives proposed by the society are practically not feasible to serve the members of a small cooperative society.
- c) The objectives proposed in bye-law No. 5 are vast. At the time of registration, the objectives are to be limited to certain extent since the bye-laws are amendable as the need arises from time to time based on the requirement.
- d) Bye-law No. 21(1) is not consistent with the provision of section 37(1) of the MSCS Act, 2002.
- e) In bye-law No. 22, the authorized share capital of the society differs in figures and in words.
- f) In the proposed bye-laws, the tenure of Board of Directors has not been provided.
- g) In the project report, the source of funds for the project has not been mentioned which is the very essential information/facts without which the viability of the society cannot be ascertained.
- h) In the membership lists of Maharashtra and Gujarat, many members have been drawn from the profession of business/service and whereas the proposed society is agro cooperative society.
- i) As per the membership list, the share capital collected from the members is around Rs. 28,000/- and whereas, the credit balance in favour of the society shows Rs. 35,000/- as per the bank certificate.

2. In view of the above deficiencies, you are hereby called upon to show cause as to why the registration of the above proposed society in the name of **Vishwajeet Agro Multi State Co-operative Society Limited, Srushti Niwas, At Post Khandke, Kaudgaon, Taluka Nagar, District-Ahmednagar-414001, Maharashtra**, under the Multi-State Cooperative Societies Act, 2002 and the rules made thereunder shall not be refused. The Chief promoter of the society or in his absence any promoter member authorized by him is called upon to appear before the Central Registrar of Cooperative Societies on 05/11/2015 at 9-00 A.M. in Room No. 224, Krishi Bhavan, New Delhi.

3. If none appears for hearing, it would be presumed that you have nothing to say in the matter and accordingly, appropriate order shall be passed as ex-parte.
