## ORDER

Under the provisions of sub-section (3) of Section 7 of the Multi State Co-operative Societies Act, 2002

Whereas the Chief Promoter of MKB (Master Knowledge in Business) Multi State Credit Cooperative Society Ltd., Office Number 303 & 306, Third Floor, G-19, Tiwari Complex, Laxmi Nagar, Delhi-110092 had submitted a proposal for registration of the proposed society under the Multi State Cooperative Societies Act, 2002 (MSCS Act, 2002).

Whereas the following deficiencies were found in the application submitted by the Society:

- 1. Bank Certificate has not been attached with the application
- 2. Viability report has not been submitted by the Society.
- 3. ID proofs have not been submitted along with the proposal.
- 4. Membership list has not been submitted by the Society.
- 5. NOC for the State of Delhi & Haryana has not been furnished as following documents have been made mandatory for the proposed credit society to submit along with their proposal of registration, which are not enclosed by the Society:-
  - A. No objection Certificate from the Registrar of Cooperative Societies of the States/U.T. where the area of operation of the society extends.
  - B. A certificate to the effect that the credential of the Chief Promoter/Promoters members have been verified by the Registrar of Cooperative Societies of the States where the head office is proposed to be located.

Whereas under the provisions of Section 7(3) of the MSCS Act, 2002 the Chief Promoter vide notice of even number dated the 31<sup>st</sup> August, 2015 was given an opportunity of personal hearing on 10<sup>th</sup> September, 2015 to contest the deficiencies.

The Chief Promoter appeared for hearing. Since the existing proposal is having deficiencies as mentioned in the notice dt. 31.08.2015 and the same was not contested, the proposed Society in the name of MKB (Master Knowledge in Business) Multi State Credit Cooperative Society Ltd., Office Number 303 & 306, Third Floor, G-19, Tiwari Complex, Laxmi Nagar, Delhi-110092 does not meet the requirements of the provisions of the Multi State Co-operative Societies Act, 2002 and rules made thereunder and therefore cannot be considered for registration.

Accordingly, the proposal is returned herewith in original. However, the society is at liberty to submit a fresh proposal and the same shall be considered as per the provisions of MSCS Act, 2002 and MSCS Rules, 2002 made thereunder.
