ORDER

Under the provisions of sub-section (3) of Section 7 of the Multi State Co-operative Societies Act, 2002

Whereas the Chief Promoter of South India Weaving Employees Multi State Cooperative Society Ltd., 18/65, Main Street Bharathi Nagar, Gandhi nagar (Post), Vellore (Dist) Pin-632006, Tamil Nadu, India had submitted a proposal for registration of the proposed society under the Multi State Cooperative Societies Act, 2002 (MSCS Act, 2002).

Whereas the following deficiencies were found in the application submitted by the Society:

- The name of the society is misleading as the word 'India' gives an impression that it covers total South India.
- 2. Certificates in respect of provision of clause (b, c & d) of sub section (1) of Section 7 have been submitted denoting clause (f, g & h) which amounts to discrepancy.
- 3. As Bye-law nos. 3(b)(1), 6(d), 43 & 44 relates to credit, the following documents have been made mandatory for the proposed credit society to submit along with their proposal of registration, which are not enclosed by the Society:-
 - A. No objection Certificate from the Registrar of Cooperative Societies of the States/U.T. where the area of operation of the society extends.
 - B. A certificate to the effect that the credential of the Chief Promoter/Promoters members have been verified by the Registrar of Cooperative Societies of the States where the head office is proposed to be located.
- 4. Bye-law no. 22(iii) relates to credit.
- 5. Mode of sending notice has not been mentioned in bye-law no. 26.
- 6. Bye-lav no. 43 relates to credit.
- 7. Bye-law no. 34(vi) is incomplete.
- 8. Bye-law No. 43(3) is applicable to banks not on societies.
- Provision relating to disqualification for being member of the Board has not been incorporated in the bye laws.
- 10. The name of the Society indicates as if the Society is a weavers society carrying out activities related to weaving however, the society is a credit society which has not been indicated in the name of the Society.

Whereas under the provisions of Section 7(3) of the MSCS Act, 2002 the Chief Promoter vide notice of even number dated the 25th August, 2015 was given an opportunity of personal hearing on 10th September, 2015 to contest the deficiencies.

Whereas none appeared for hearing. Since the existing proposal is having deficiencies as mentioned in the notice dt.25.08.2015 and the same was not contested, the proposed Society in the name of South India Weaving Employees Multi State Co-operative Society Ltd., 18/65, Main Street Bharathi Nagar, Gandhi nagar (Post), Vellore (Dist) Pin-632006, Tamil Nadu, India

does not meet the requirements of the provisions of the Multi State Co-operative Societies Act, 2002 and rules made thereunder and therefore cannot be considered for registration.

Accordingly, the proposal is returned herewith in original. However, the society is at liberty to submit a fresh proposal and the same shall be considered as per the provisions of MSCS Act, 2002 and MSCS Rules, 2002 made thereunder.
