ORDER

Whereas the Chairperson, Visakha Mahila Co-operative Society Ltd., D.No. 18-197, Opp. Vuda Apartments, H.B. Colony (Post), Visakhapatnam-530022 has submitted an application to issue certificate of registration to the Society u/s 103 of the Multi State Cooperative Society Act, 2002, citing that the Society has attracted deemed Multi State status consequent to reorganization of the erstwhile State of Andhra Pradesh into states of Telangana & residual Andhra Pradesh.

Whereas, the Society is registered under Andhra Pradesh Mutually Aided Cooperative Societies Act, 1995 with registration No.AMC/VSP/DCO/2000/458 dated 31/7/2000 and as per the existing bye-laws of the society the area of operation of the society is the entire State of erstwhile Andhra Pradesh.

Whereas, this office vide letter of even number dated 29/5/2015 requested the Society to furnish the State-wise list of its members and this office vide letter of even number dated 18/8/2015 wrote to Registrar of Cooperative Societies of the State of Telangana with a request to check the genuineness of the members of Telangana State indicated by the above society and to submit a report to this Department for taking further action on the subject.

Whereas, the Registrar of Cooperative Societies of the State of Telangana vide his letter RC No. 6483/2015/MSCS, Dt. 29/6/2016 (copy enclosed) has conveyed to this office that out of 52 members, the Field Staff was able to trace out only 34 individuals. Among 34 individuals, only 9 members are proved as genuine members under their jurisdiction. RCS, Telangana has also informed that the society has shown the name of a person who was presently residing in USA and she is not a member of the society as confirmed by her husband. It is therefore observed that the membership list submitted by the Society is not genuine and reliable. Society has submitted false information to CRCS.

In view of the above, registration of Visakha Mahila Co-operative Society Ltd., D.No. 18-197, Opp. Vuda Apartments, H.B. Colony (Post), Visakhapatnam-530022 by deemed registration of the Society u/s 103 of the Multi State Cooperative Society Act, 2002 **cannot** be considered.
