ORDER

Under the provisions of sub-section (3) of Section 7 of the Multi State Co-operative Societies Act, 2002

Whereas the Chief Promoter of Bharathi Inter-State Credit and Multi Purpose Cooperative Ltd., Vivekananda IX/81A, East Pallor, Mahe,673310 (Puducherry) had submitted a proposal for registration of the proposed society under the Multi State Cooperative Societies Act, 2002 (MSCS

Whereas the following deficiencies were found in the application submitted by the Society:

- 1. In Bye-law no. 4(j), definition of persons is not consistent with Section 25 of the MSCS Act,
- 2. Since the Society is a credit and a multi-purpose society, the following documents have been made mandatory for the proposed Credit/ Multi-Purpose society to submit along with their proposal of registration, which are not enclosed by the Society:-

A. No objection Certificate from the Registrar of Cooperative Societies of the States/U.T. where the area of operation of the society extends.

- B. A certificate to the effect that the credential of the Chief Promoter/Promoters members have been verified by the Registrar of Cooperative Societies of the States where the head office is proposed to be located.
- 3. Bye-law No. 15 is not consistent with section 29(b) of the MSCS Act 2002 as provision of minimum level of services has not been specified.
- 4. Bye Law No. 28 is not consistent with Rule 13(1) of the MSCS Rules, 2002.
- 5. Mode of sending notice has not been mentioned in bye-law no. 30(c).
- 6. Resolutions submitted by the Society are not consistent to Rule 3(4 &5) of the MSCS Rules, 2002 as it does not clarify who shall be the signing authority on behalf of the Society.

Whereas under the provisions of Section 7(3) of the MSCS Act, 2002 the Chief Promoter vide notice of even number dated the 20th September, 2016 was given an opportunity of personal hearing on 3rd October, 2016 to contest the deficiencies.

Whereas none appeared for hearing. Since the existing proposal is having deficiencies as mentioned in the notice dt. 20th September, 2016 and the same was not contested, the proposed Society in the name of Bharathi Inter-State Credit and Multi Purpose Cooperative Ltd., Vivekananda IX/81A, East Pallor, Mahe,673310 (Puducherry) does not meet the requirements of the provisions of the Multi State Co-operative Societies Act, 2002 and rules made thereunder and

Accordingly, the proposal is returned herewith in original. However, the society is at liberty to submit a fresh proposal and the same shall be considered as per the provisions of MSCS Act, 2002 and MSCS Rules, 2002 made thereunder.
