ORDER

Under the provisions of sub-section (3) of Section 7 of the Multi State Co-operative Societies Act, 2002

Whereas the Chief Promoter of Kishan Agriculture Development and Marketing Cooperative Societies Ltd., H.No. 41 Village Shuklapur Post Kuiyan Distt. Hardoi-241001, U.P had submitted a proposal for registration of the proposed society under the Multi State Cooperative Societies Act, 2002 (MSCS Act, 2002).

Whereas the following deficiencies were found in the application submitted by the Society:

- It has been observed that in Form No. 1 and the bye law No. 3, the proposed area of operation of the Society is confined to only one State i.e, revenue territories of Uttar Pradesh. Hence the minimum requirement of atleast 50 members from two States is not fulfilled.
- 2. The Society does not fulfill the mandatory condition of two States.
- 3. The proposed society has submitted members' list of only one state i.e. Uttar Pradesh.
- 4. Membership list submitted by the Society is incomplete and not in prescribed format.
- 5. Section 7 Certificates have not been enclosed with the application.
- 6. Bank Certificate and Viability report have also not been attached with the application.
- 7. Resolutions have not been enclosed with the application.
- 8. Information of interim board/list of Promoters have not been given by the Society.
- 9. ID proofs have not been attested by the Chief Promoter.
- 10. The definition of the Society is required to be provided at the end of the bye-law.
- 11. In bye-law No. 13, the proviso as required u/s 25(4) has not been provided.
- 12. Since bye-law no. 60 relates to credit for which the following documents have been made mandatory for the proposed credit society to submit along with their proposal of registration, which are not enclosed by the Society:-
 - A. No objection Certificate from the Registrar of Cooperative Societies of the States/U.T. where the area of operation of the society extends.
 - B. A certificate to the effect that the credential of the Chief Promoter/Promoters members have been verified by the Registrar of Cooperative Societies of the States where the head office is proposed to be located.

Whereas under the provisions of Section 7(3) of the MSCS Act, 2002 the Chief Promoter vide notice of even number dated the 1st September, 2016 and subsequent letter dated 8th September, 2016 was given an opportunity of personal hearing on 19th September, 2016 to contest the deficiencies.

Whereas none appeared for hearing. Since the existing proposal is having deficiencies as mentioned in the notice dt. 1st September, 2016, and the same was not contested, the proposed Society in the name of Kishan Agriculture Development and Marketing Cooperative Societies Ltd., H.No. 41 Village Shuklapur Post Kuiyan Distt. Hardoi-241001, U.P does not meet the requirements of the provisions of the Multi State Co-operative Societies Act, 2002 and rules made thereunder and therefore cannot be considered for registration.

Accordingly, the proposal is returned herewith in original. However, the society is at liberty to submit a fresh proposal and the same shall be considered as per the provisions of MSCS Act, 2002 and MSCS Rules, 2002 made thereunder.
