ORDER

Under the provisions of sub-section (3) of Section 7 of the Multi State Co-operative Societies

Act, 2002

Whereas the Chief Promoter of SJALU Agro Multi State Co-operative Society Limited, 163-F, Second Floor, JMJ Arul Building, Kalappaikaran Street, Balaji Nagar, Salem-636 016, Tamil Nadu had submitted a proposal for registration of the proposed society under the Multi State Cooperative Societies Act, 2002 (MSCS Act, 2002).

Whereas the following deficiencies were found in the application submitted by the Society:

- 1. Bye-laws have not been given serial numbers.
- 2. The proposed society has submitted members' list from only one state i.e. Tamil Nadu.
- 3. Membership list submitted by the Society is not in the format annexed to MSCS Rules, 2002.
- 4. Form-1 is not submitted by the Society.
- 5. Certificates under Section [7 [1(b,e,d)] of the MSCS Act, 2002 have not been enclosed with the application.
- 6. Resolutions have not been enclosed with the application.
- 7. Bank Certificate and Viability report have also not been attached with the application.
- 8. Bye-law relating to Deposits relate to credit for which following documents have been made mandatory for the proposed credit societies to submit along with their proposal of registration, which are not enclosed by the Society:-

A. No objection Certificate from the Registrar of Cooperative Societies of the States/U.T. where the area of operation of the society extends.

B. A certificate to the effect that the credential of the Chief Promoter/Promoters members have been verified by the Registrar of Cooperative Societies of the concerned States.

Whereas under the provisions of Section 7(3) of the MSCS Act, 2002 the Chief Promoter vide notice of even number dated the 21st September, 2016 was given an opportunity of personal hearing on 3rd October, 2016 to contest the deficiencies.

Whereas Chief Promoter appeared for hearing. Since the existing proposal is having deficiencies as mentioned in the notice dt. 21st September, 2016 and the same was not contested, the proposed Society in the name of SJALU Agro Multi State Co-operative Society Limited, 163-F, Second Floor, JMJ Arul Building, Kalappaikaran Street, Balaji Nagar, Salem-636 016, Tamil Nadu does not meet the requirements of the provisions of the Multi State Co-operative Societies Act, 2002 and rules made thereunder and therefore cannot be considered for registration.

Accordingly, the proposal is returned herewith in original. However, the society is at liberty to submit a fresh proposal and the same shall be considered as per the provisions of MSCS Act, 2002 and MSCS Rules, 2002 made thereunder.
