ORDER

Under the provisions of sub-section (3) of Section 7 of the Multi State Co-operative Societies Act, 2002

Whereas the Chief Promoter of APS Multi State Cooperative Credit Society Ltd., 12 A, Jeevan Nagar, Madakulam Main St, Madurai-625003 had submitted a proposal for registration of the proposed society under the Multi State Cooperative Societies Act, 2002 (MSCS Act, 2002).

Whereas the following deficiencies were found in the application submitted by the Society:

- 1. It is not clear that the abbreviation APS in the name of the society stands for what?
- 2. Instead of submitting the Bank Certificate in Original, the Society has enclosed a copy of the Pass Book.
- 3. Since the Society is a Credit Society, the following documents have been made mandatory for the proposed credit societies to submit along with their proposal of registration, which are not enclosed by the Society:-:-
 - A. No objection Certificate from the Registrar of Cooperative Societies of the States/U.T. where the area of operation of the society extends.
 - B. A certificate to the effect that the credential of the Chief Promoter/Promoters members have been verified by the Registrar of Cooperative Societies of the concerned States.

Whereas under the provisions of Section 7(3) of the MSCS Act, 2002 the Chief Promoter vide notice of even number dated the 10th August, 2016 was given an opportunity of personal hearing on 22nd August, 2016 to contest the deficiencies.

Whereas none appeared for hearing. Since the existing proposal is having deficiencies as mentioned in the notice dt. 10th August, 2016 and the same was not contested, the proposed Society in the name of APS Multi State Cooperative Credit Society Ltd., 12 A, Jeevan Nagar, Madakulam Main St, Madurai-625003 does not meet the requirements of the provisions of the Multi State Co-operative Societies Act, 2002 and rules made thereunder and therefore cannot be considered for registration.

Accordingly, the proposal is returned herewith in original. However, the society is at liberty to submit a fresh proposal and the same shall be considered as per the provisions of MSCS Act, 2002 and MSCS Rules, 2002 made thereunder.
