**NOTICE**

As you may be aware that multi-State cooperative societies registered under the provisions of the Multi-State Cooperative Societies (MSCS) Act, 2002 are functioning as autonomous cooperative organizations accountable to their members. The role of the members, Board, General Body and Central Registrar are defined in the said Act. The powers of the Central Registrar/Central Government under the MSCS Act, 2002 are exercisable only in certain provisions of section 77, 78, 79, 108, 122 and 123 of the said Act.

2. It has been brought to the knowledge of this Department that one of the multi-State cooperative societies functioning under the MSCS Act, 2002, namely **Adarsh Credit Cooperative Society Ltd.** (Address : 2<sup>nd</sup> Floor, 14, Vidya Vihar Colony, Opposite Hotel Fortune Landmark, Usmanpura, Ahmedabad-380013), Gujarat, is involved in misuse and diversion of funds to shell companies/associate companies/concerns owned by assessee group persons/dummy directors in the garb of loans and commission income for investment in real estates and other irregularities and the same has been called upon to show cause why liquidation proceedings should not be initiated against Adarsh Credit Cooperative Society Ltd.

3. In this connection, attention of members/investors/public is invited to the circular issued by this Department dated 3<sup>rd</sup> July, 2017 in which all the multi-State cooperative societies have been directed to display the following in the entrance of the society, branches, in the forms relating to various deposits and also to post in their websites, if any, maintained :-

*"Multi-state cooperative societies are functioning as autonomous cooperative organizations accountable to their members and not under the administrative control of the Central Registrar, Ministry of Agriculture and Farmers' Welfare. Therefore, the depositors/members are advised to take decision for investing deposits based on the performance of the society at their own risk. Central Registrar, Ministry of Agriculture and Farmers' Welfare does not provide any guarantee for these deposits."*

4. In view of the above, members/investors/public are hereby advised that while investing their funds/deposits in the multi state cooperative societies, may take such decision based on the performance of the society, at their own risk.
