Any members / depositors / creditors and / or any other person, if any, who fails to submit his "Affidavit of Proof of Debt" along with supporting original documents, within the time limit as aforesaid will be excluded from the benefit of any distribution of dues / amounts/ claims before his debt is proved, or, as the case may be, from objecting to such distribution.

Any members / depositors / creditors and / or any other person, if any, who has already filed an affidavit proving the debt / claims in prescribed form, need not submit the same again, but after verification of the list with Liquidator.

Any members / depositors / creditors and / or any other person, if any, who has sent in his proof, if so required by notice in writing from the Liquidator, shall either in person or by his advocate, attend the investigation of such debt or claim at such time and place as shall be specified in such notice and shall produce such further evidence of his debt or claim as may be required.

The settlement of dues/ claims are subject to recovery of dues and loans from debtors and defaulters/ persons responsible for losses to the said society and availability of adequate funds.
