**ORDER**

(Under Section 86 of the Multi-State Cooperative Societies Act, 2002)

Whereas, vide this Office's Order of even No. dated 06.02.2018, District Deputy Registrar, Cooperative Societies, Osmanabad O/o the Commissioner for Cooperation & Registrar of Cooperative Societies, Pune, Government of Maharashtra was appointed as Liquidator to wind up "Shubh Kalyan Multistate Cooperative Credit Society Ltd., Dilipnagar, Havargaon, Kallam, Osmanabad-413507, Maharashtra (Regn No. MSCS/CR/458/2011)" under the provisions of the Multi-State Cooperative Societies Act, 2002 and Rules made thereunder. Later vide Order dated 04.04.2022, Assistant Registrar, Cooperative Societies, Tal. Kalamb, District Osmanabad, Maharashtra was appointed as Liquidator of above Society in place of District Deputy Registrar, Cooperative Societies, Osmanabad.

2) Now, the Commissioner for Cooperation & Registrar of Cooperative Societies, Government of Maharashtra vide letter dated 18.05.2023 has requested to appoint Assistant Registrar, Cooperative Societies, Tal. Bhum, District - Osmanabad as Liquidator in this Society.

3) Therefore, after careful consideration of the facts, I, Vijay Kumar, Central Registrar of Cooperative Societies, hereby appoint Assistant Registrar, Cooperative Societies, Tal. Bhum, District Osmanabad, Office of Commissioner for Cooperation & Registrar of Cooperative Societies, Government of Maharashtra as Liquidator of Shubh Kalyan Multistate Cooperative Credit Society Ltd., Dilipnagar, Havargaon, Kallam, Osmanabad-413507, Maharashtra, until further orders, in place of Assistant Registrar, Cooperative Societies, Tal. Kalamb to finalise the liquidation proceedings of the Society.

4) Assistant Registrar, Tal. Kalamb shall hand over the charge of the liquidation work to the Assistant Registrar, Cooperative Societies, Tal. Bhum, District Osmanabad with immediate effect and apprise him of the liquidation proceedings undertaken by him so far. The Liquidator is requested to expedite the liquidation proceedings and submit status report showing the progress made in liquidation work of the Society on quarterly basis to this office.
