“Rubi Credit Cooperative Society Ltd, Shakun, Narsinghpura Faisagar Road, Ajmer, Rajasthan-305001” (MSCS/CR/407/2011) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules made thereunder (hereinafter referred as Act).

2) The Registrar of Cooperative Societies, Government of Rajasthan vide letter No. 15(19) (10) Savira/ Bank-1/Rubi-MSCS/2022 dated 31.10.2022 has forwarded an inspection report of Society conducted by the Deputy Registrar, Cooperative Societies, Ajmer, under Section 108 of the Act. It is reported that Society is neither functioning at its registered address nor at its temporary address. Society's record is with two police stations and previous officials of the Society and newly elected Board of Directors have resigned. Besides this, the Society has not submitted its mandatory Annual returns after financial year 2017-18.

3) Therefore, it appears that the Society is not functioning at its registered address as per the provision of the Act, Rules and its approved bye-laws. Accordingly, it has been decided to initiate winding up process of the Society under the provisions of the MSCS Act, 2002 and Rules made thereunder. In case of any objections to the proposed winding up, the same may be brought to the Notice of this Authority within 15 days from the date of uploading this Notice on the office website i.e. www.msccs.dac.gov.in, failing which, it will be presumed that the Society has nothing to say and action would be initiated to wind up the Society under the provisions of MSCS Act, 2002 and rules made thereunder.
